7. Reports of Special Committees :

Rides - Roger Robinson going for a ride Tuesday Oct 11th to Loon Lake, D Bar-walk around Lodge area, Chasm Falls and Trailside for lunch. Leaving Standish Wolf Pond Rd at 9:30.

Ironman - nothing at this time

Adopt a Highway - 7 volunteers picked up about 21 bags of garbage on our 4 mile stretch. 8 members would be the perfect number for cleaning the highway. We had fun and went for a ride to Trailside for lunch afterward.

Trail - No official information as of yet.

Our lawyer Dennis Phillips has given access to Fred Monroe from Warrensburg so he can do pro bono research on our behalf.

Jerry Delaney was not able to join us this evening but he has acquired \$3000.00 from the town council review board that he is a part of. That money will go directly to the lawyer lessening the amount due at the end. Jerry has not yet gotten any money from the town councils themselves.

Looking at our state land issue we see we never had authority to ride the railbed from Conclain Lodge in Lyon Mountain to the state land boundary. This is owned by Woodfield

Trail Cont. Investments managed by Huber Resources in Maine. They had previously given us permission to ride from Standish road up over the mountain ending up in the Standish village. In talking with Huber Resources about getting legal authority to ride the rail bed, we found out since we did not renew our lease, even though we were not told it was up, they gave that land lease to Dave Siskavich for his ATV Club to use. He opened a riding park that he charges people to ride on and that area includes our Steve McLean memorial trail.

Huber Resources has no problem with us using the rail bed trail but again it is up to the hunting clubs.

Jerry Delaney, town of Saranac councilman, has a good friend in Little Camp who is going to set up a 3 way meeting with these hunting camps. There should not be a problem with us using this trail except for hunting season. At Conklin's Lodge there is a gate. It is gated during hunting season. We need to establish a firm permitted right of use at that segment of trail so that when we go to the state with the lawyer on the southern half down at the village of Standish we can show it is a full connector. We will put up gate if needed.

At the Franklin County group Shawn Reynolds, State Senior Forester for this area would like to have Outbackriders input on the Chazy Highlands unit management plan which includes the trail we are fighting for.

Dennis has been emailing Shawn about what is needed and Dennis wrote a letter describing our club and snowmobile clubs use of this area and access availability for the older ATV riders who are not able to access the more intricate trails leading to

the beauty of the forest. This trail segment provides a connection for Franklin and Clinton County allowing great access to the wilderness for people of all ages.

Brush loggers wants the railroad bed open to the public so they may sell a recreational lease to the state. Very strong potential that it will turn into a state conservation easement for recreation.

Steve McLean trail no longer belongs to us. You need to belong to Dave Siskavich club to ride it. Dave called Gordon Duprey asking him to remove Steve's trail from our website page.

Overall Jerry Delaney feels we are still in a very good position. Keep our fingers crossed.
